



**DECLARATION OF CONSENT

The Ernst Ludwig Ehrlich Studienwerk e.V. uses your data for the in-house database and for the network with and between the scholarship holders. Your data represent the basis for the ability of the educational funding bodies to perform the tasks of financial and intellectual support, and for our scholarship holders and alumni to be included in the work and information of the scholarship fund.

In line with this, your basic personal data including your name, subject of study, educational institution, regional group, private address, telephone number, e-mail address, and bank details are processed within the Ernst Ludwig Ehrlich Studienwerk in-house database and used to perform the tasks of financial and intellectual support. Other scholarship holders, alumni, and advisors only receive access to your surname, first name, e-mail address, regional group, and subject.

Commercial use of your data is prohibited.

I additional consent to requests for and comparisons of data with the other advanced educational funding bodies, the agencies for educational support, and the Federal Foreign Office to exclude the possibility of double funding. For this purpose, individual sites of educational institutions submit random samples of limited personal data, i.e. names, including all given names, address, date of birth, and location of educational institution, to the Federal Ministry of Education and Research. It compares the data with that of the other advanced educational funding bodies, the BAföG agencies, and the Federal Foreign Office. The data are deleted after use. Should you refuse to consent, it is possible that you will be excluded from the financial support of the Ernst Ludwig Ehrlich Studienwerk.
